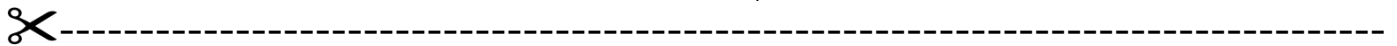

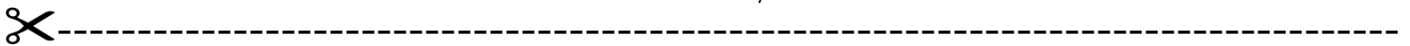

There is a \$10 charge per piece for any work not collected at the specified time. If you cannot collect work yourself at this time please arrange for a friend as your authorised agent to pick up your work for you.

CONDITIONS OF ENTRY

Entry Fee: \$20 per work submitted.

Entry Form: To be returned with payment by 4pm Friday 26th Nov 2021 by mail to Belling Community Arts Council, PO Box 469, Belling 2454, or by hand to the Nexus Community Gallery. Signed entry form is binding and no alterations to the title or price will be allowed.

Delivery: All works to be delivered to the Nexus Community Gallery, Old Butter Factory on Friday 3rd Dec between 1 and 4pm. No late deliveries will be accepted.

Opening: No official opening due to COVID restrictions. Exhibition open from 10am Sunday 5th Dec.

Collection: Unsold works to be collected by the artist or their authorised agent from the Gallery on Friday 14th Jan between 1.00 and 4.00pm. Any work not collected by 4pm will attract a \$10 late fee and be disposed of at the committee's discretion.

Commission: All works must be for sale. For works sold a commission of 30% of the purchase price will be charged.

Payments to Artists: Payment for sold work will be made within 28 days of close of exhibition.

The Works: No work entered can have appeared in any previous member's show.

2D works must be properly framed, dry and ready for display with D-rings on the back and cord, not wire, strung between the D-rings.

The back must be clearly marked with the artist's name, phone number and retail price of the work.

Size limitations apply – for 1 work entered max size 125cm x 125cm, if 2 works max size 60cm x 60cm.

3D works must not exceed 20kilos in weight.

The organizers reserve the right to reject or withhold any entry.

Insurance: Exhibitors must arrange their own insurance if required. All care will be taken but no responsibility accepted for loss or damage.

Publicity: The Arts Council may allow works on display to be reproduced by the media during the exhibition. The signed entry form is evidence of the artist's consent.

Roster: Participating artists are asked to make themselves available for roster duty during the exhibition.

The exhibition roster is: 7 days a week from 10am to 4pm in 2 shifts - 10am to 1pm and 1pm to 4pm.
